- 1. Two Copies of this petition are to be completed if this petition is presented in paper form. ALL questions must be answered before presenting the petition to an ACGL Lodge.
- 2. The petitioner must be able to present a currently valid dues card or receipt for dues from each Lodge in which he holds membership.
- 3. A currently valid Certificate of Good Standing must be obtained from each Lodge in which he holds membership, and will automatically be requested through Grand Lodge channels by the Grand Secretary. (See No. 4 below) . If the petitioner submits such a certificate with his petition, a copy must be sent to the Grand Secretary.
- 4. When received and officially read and accepted by the Lodge for the first time, the Secertary of the Lodge shall ensure that all questions have been answered, and after completeing the middle section of the third page, send the second copy of the petition (duplicate) to the Grand Secretary as soon as possible.
- 5. When elected to affiliation by ballot, the the Brother concerened may not consummate membership or be reported as affiliated until the mandatory Certificate(s) of Good Standing is(are) received and duly filed with the Lodge.
- 6. Any affiliation consummated in violation of the Laws of this or any other Grand Lodge concerned shall be subject to nullification when and if investigation reveals that such violation exists.
